Draft presentation of proposed rule changes was prepared by the Chairman of Rules Committee.

Changes, amendments, and corrections were discussed and approved by the Plenary for the updated version of FAI Sporting Code Section 9, Chapter 8 .

FAI SC Section 9 Ch7 has changes as agreed to the proficiency diploma removing duration from the gold requirements and changing the requirements for the number and type of competitions to have entered. The text is also added to allow a 60 km radius around an antipode for circumnavigation via antipodes.

8.1 REVIEW OF THE CIG CALENDAR OF EVENTS

There was no CAT 1 or CAT 2 event in 2023 within FAI CIG

Represented countries gave the following information about events in 2023.

Austria, Belgium, France Italy had no events and activities to mention it.

Poland: There was a big event - in August in Poland - 1st Helicopter Rally with eliminations to the Polish National Helicopter Team, which will be ready to compete this year. The event took place under the auspices and involvement of the CIG President, with the participation of 20 crews, 70 helicopters taking part in the World Helicopter Rally and an audience of 20,000 people.

Czech Republic: Czech Heli Fun Meeting 2023 Kunovice, 14. – 16.4.2023 (Bulletin#1). There were about 20 - 30 participants (crews, judges, helpers, guests) from Poland, Czech, UK, and Germany

Germany: 25. - 29.5.2023 Flight safety training (FST) in Mengen (EDTM) About 30 - 40 participants, 7 crews, 15 judges, helpers, guests. 30.08.-03.09.2023 ODHM in Alkersleben (EDBA) About 50 – 70 participants, 6 crews, 18 judges, helpers, guests. Both events were supported and in cooperation with DHC e.V and SHeV.
